

On October 21, 2025, the Court issued an Order on Stipulation to Stay addressing the October 16, 2025 Stipulation to Stay Litigation Schedule in Light of Lapse of Appropriations filed by the Claimants and parties to these subcases represented by counsel. The Court vacated several deadlines set in the September 18, 2025 litigation schedule¹, noting the deadlines would be rescheduled as soon as possible. The Court maintained previously scheduled status



I. PROCEDURAL BACKGROUND

On September 16, 2025 the United States as Trustee filed a Stipulation to Amend Litigation Schedule/Request for Expedited Consideration. According to the Stipulation, the Nez Perce Tribe and the State of Idaho as well as many of the other parties concurred with the Stipulation.

The proposed litigation schedule has dates and deadlines for three categories of subcases: the Allotment or DCMI claims; the Springs Claims; and the Instream Flow claims. The dates and deadlines which have changed impact the U.S. and the Nez Perce Tribe as well as the State of Idaho.

II. DISCUSSION

The movants and the other parties continue to work effectively on settlement. Regular settlement conferences and additional meetings assist in moving the litigation and settlement discussions forward.

III. CONCLUSIONS

Based on representations that settlement discussions are ongoing, and that the changes to these deadlines does not delay Summary Judgment or Trial Schedules, the Court grants the Motion to Amend the Litigation Schedule.
